From the Treasurer

We thank our regional association and stakeholder contributors to our voluntary levy scheme as it enables this organization to function and provide the framework to support our objects and goals. It is levy collection time. This year we are targeting this financial quarter to streamline the process and give us certainty going into our 2022-2023 financial year.

The <u>LCGWC</u> is a non-governmental, not for profit association that collects subscriptions from Limestone Coast grapegrowers based on Hectares via their regional association. It maintains some reserves that

collect interest from term deposits. The Committee of Management (COM) and high functioning sub-committees implement the LCGWC <u>Strategic Plan</u> through a range of activities that oversight the Councils annual turnover of around \$230,000.

It is important the council retain appropriate cash reserves and continues to build this so we can invest in activities like

- 2018-2021 Spore traps -\$17500 over 3 years. Number of SARDI owned traps positioned around Coonawarra. Reports available in our Library.
- 2018-ongoing Mixed Dozen Wine Trails \$30000 initially, \$2000pa ongoing until 2024. (\$36000 in total)
- 2016-Submissions into the parliamentary enquiry resulting in a 10-year moratorium on fracking \$18,900
- 2003-2007 water allocation plan arrangements including supporting reviewing the revised allocations \$52,000 With the next review of the Limestone Coast WAP occurring currently, further financial support maybe appropriate to ensure the Limestone Coast Wine Industry is not disproportionately impacted in the WAP process

Fully audited financial results were presented at the LCGWC AGM in November plus update of FY 22/23 1st Qtr, with sub-committee activities remaining cash positive leading into the new calendar year.

Biosecurity – working with Vine Health Australia & Australian Grape & Wine...

Biosecurity relationships is within the scope of the technical sub-committee. [Focus and Initiate]

- <u>Vine Health Australia</u> is funded mainly by statutory levies within South Australia.
 - o Inca Lee (CEO, VHA) and Suzanne McLauchlan (Senior technical officer, VHA) are in contact regularly and report into our technical committee meetings.
 - We encourage Limestone Coast stakeholders to use <u>best practice</u> and tools provided by VHA, including the Phylloxera <u>Heat Shed</u> in Wrattonbully.
- Australian grape and wine (AGW) are our national lobby and work closely with Wine Australia on all aspects of biosecurity. AGW is funded by professional memberships.
 - Ben Harris and Ulrich Grey-Smith have undertaken training and will be points of contact if an incident occurs that needs local management. Luckily none to so-far.
- Strategic thinking and tasks in this area rely on *volunteers and voluntary levies from the 6 regional associations and contributing vineyards.
 - *Thank you to the companies, organizations and individuals that are involved by technical committee attendance, your inputs in this area are invaluable.
 - Spray Drift reminders and advocacy are important and continue to be active in this. We will be looking for updates into the <u>Meso-nets</u> network that will be rolled out in our region the coming year.

Wine Australia grants – delivering the 'Regional Program' in SA South...

Within the scope of the technical committee. This rolling-contract is self-contained with allowances for approved activities. Approved activities new and on-going are,

- Soil Carbon Stocks (delivered by Adelaide University) soil carbon measures by vineyard setup and treatments.
- Smoke quality sensor network by region (delivered by Latrobe University) ongoing, get an update on the 7th February 2022.
- o Short-clip vignettes on Vimeo and YouTube seven clips heralding past RDE for varying audiences, ongoing. Steering committee is Cath Kidman, Lachie Travis & Peta Baverstock. Videographer is Ockert LeRoux.
- Revised Edition Unearthing Viticulture updating the climate chapters. Soft launch soon.
- Priority setting session for the next 5-year contract facilitated session will be in May 2023.
 - Diary marker Thursday 18th May 2023, details soon.

Landscapes Grants – Adaptive Agriculture – Sustainability in the Greater Limestone Coast

Within the scope of the technical committee. This one-off grant is financially self-contained with allowances for approved activities.

- Approved activities will be delivered by AWRI's Sustainable Winegrowing Australia team.
 - The funding will help off-set training costs for accredited entities and engage companies yet to register.
 - Three workshops and 3 case studies, with adoption of Sustainable Winegrowing Australia certification the goal.
 - Acquittal is in September 2023.
- Next Workshop will be in July 2023,

Mixed Dozen Wine Trials Sub-Committee

- Financial support is from the local government co-cash and from LCGWC retained earnings (your voluntary levies at work)
- Financial support is only secured until April 2023, with the year-3 tbc and end of licenses in year-4.
 - We will be looking at either continuing with cash inputs from the regulars (LCLGA, Southern Grampians Shire, Glenelg shire and us) or, if another auspice organization can be found. The choice depends on voluntary levy support & if it features in our strategic plans.
- Encouraging all producers with cellar doors and bookable experiences to use the free Australian Tourism Warehouse <u>log-in</u> to create or update your tourism offering.

With both the Lower Limestone Coast Water allocation plan (LLSCWAP) and the Upper Limestone Coast Water Allocation Plan (ULSCWAP) in consultation review there has been discussion within the COM on collaborative approaches into getting the most out of the plans. The <u>Landscapes Board SA</u> has set up advisory groups that will inform decisions. At the recent state and regional organization forum at the National Wine Centre in Adelaide (attended by Helen and me) we were asked to provide a snapshot of what the limestone coast at its regions offers to different audiences.

The two-day event had a session on regional brand stories. This task to express and verbalize our strengths and features to our tourists, domestic and export markets, and other wine regions was an opportunity to show AGW, Wine Australia and DFAT what we are achieving in these days of climate change, trade barriers, and over-supply.

We

- 1. reported on our headlines, our communications focus, and commercial imperatives.
- 2. We did a plan on a page with vision, strategy pillars, and promise.
- 3. We looked at advocacy hot issues.
- 4. All regions were given the opportunity to talk to these three prewritten templated documents and discuss the common ground and the common issues, and then workshop possible solutions and actions.

AGW speak to government on our behalf and other than these annual face to face events there are bimonthly online forums are an opportunity for regions to speak directly into national wine-sector discussions.

Some of the big topics are Sustainable Winegrowing Australia uptake, international tourism, Southeast Asia export focus (including India), national container deposit schemes, supply chain issues, oversupply/undersupply, regional identity, DFAT in India, and available funding help.
