**Provide a forecast for the industry.** This will include economic data and industry predictions at different time intervals (5, 10, 20 years). It will provide evidence for defining the industry as new and emerging, growing, maturing or declining.

**Identify government regulations affecting the industry.** This will Include any recent and emerging laws, licenses and regulations relating to the industry.

**Explain the unique position of the Limestone Coast within the industry.** This will include an overview of data of direct and indirect competition.

**List potential limitations and risks.** This will include factors that might negatively impact the industry and what you foresee in the short-term and long-term future. It will outline information about driving forces such as new regulations, technology, globalization, competitors and changing customer needs.
