VineHealth Australia Report - Warren Birchmore & Krysteen McElroy.

Warren Birchmore presented, salient points were

- Introducing Sam Scarett to the VineHealth team who will be in Padthaway and Coonawarra in early December.
- Fruit Fly Vintage planning reminders & plant health certificates, especially out of Riverland and Adelaide Plains /Salisbury North.
- Meetings with regional associations is ongoing
- South Australian vineyard register review is now complete will upgrade critical software.
- VHA working with PIRSA on outbreak logistics, joint control.
- Yarra Valley phylloxera fact sheets have been released
- · Regional Stats for LC total as per Pete Bissell request
- Applications for the Inaugural Biosecurity Champion have been received, with winner announced soon

Krysteen & Warren salient discussion points

- Cross-border activities, Tourism & Forestry in particular.
- Also risks with SA Power networks vehicle and foot traffic,
- Movement of other agricultural & non-agricultural equipment (including drill mining trucks and other.)
- Target contractors to attend the field days,
- education of sub-contractors.
- Wrattonbully Head is available to these contractors.
- This may require letterbox drop to all associated industries and companies (suggestion from Paul Petrie)
- VHA will continue to produce the annual SA Grape Utilisation Survey, which includes a vineyard register for SA. VHA is working with Wine Australia on the national vineyard register, but this will take time and considerable investment in new technology.
- Initial frost mapping 10m resolution too low to be of use.
